Plan Year - September 1, 2023 through August 31, 2024

This is a summary of the annual report for the Carpenters Health and Welfare Trust Fund for California, Employer Identification Number 94-1234856, a multiemployer health and welfare plan, for the period September 1, 2023 through August 31, 2024. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees of the Carpenters Health and Welfare Trust Fund for California has committed the Fund to pay certain Medical, Hospital, Dental, Orthodontia, Prescription Drug, Vision, Hearing Aid, Physical Examination, Supplemental Disability, Mental Health and Substance Abuse claims under the terms of the Plan.

Insurance Information:

The Plan has contracts with Kaiser Foundation Health Plan, Inc. to pay certain medical, hospital, mental health, substance abuse, and prescription drug claims, Voya Financial, Inc. to pay all accidental death, dismemberment, life insurance claims, and all stop loss claims incurred under the terms of the plan. The total premiums paid for all contracts for the Plan year ending August 31, 2024 were \$318,664,622.

Basic Financial Statement:

The value of Plan assets, after subtracting liabilities of the Plan, was \$727,519,815 minus premiums and self-funded claims payable of \$82,190,265, minus claims incurred but not reported of \$33,117,000, minus bank of hours liability of \$181,393,000, equals \$430,819,550 as of August 31, 2024, compared to \$751,019,326 minus premiums and self-funded claims payable of \$78,509,190, minus claims incurred but not reported of \$27,724,000, minus bank of hours liability of \$172,469,000, equals \$472,317,136 as of September 1, 2023. During the Plan year, the Plan experienced a decrease in its net assets of \$41,497,587. This decrease included unrealized appreciation or depreciation in the value of Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year.

During the plan year, the Plan had total income of \$496,122,647; including employer contributions of \$400,757,286, participant contributions of \$30,941,340, realized gains of \$2,850,937 from the sale of assets, losses from investments of \$60,925,063, and other income of \$648,021.

Plan expenses were \$537,620,233. These expenses included \$14,389,067 in administrative expenses, \$128,258 in investment expenses, \$318,664,622
